This course will help judges understand the changes in the new rules and enhance their skills in the Children's Long Program. Participating in this course is essential for judges who want to judge in 2024, as all national and international competitions in Asia will follow the new rules for the AGG short program. Even those who already possess an international license must understand and study the new short program course. If you are interested in studying AGG's rules or obtaining a judge's qualification, I encourage you to participate in this Judges Course.
