DELEGATIONS INVITED	The Royal Spanish Gymnastics Federation invites all IFAGG Members in good standing. All IFAGG members who are members of Mediterranean countries are allowed to register for the Mediterranean Countries AGG Competition.
EVENT FORMAT	Only IFAGG members in good standing can register participating groups. <u>Long/Short Program/Mixed team</u> Children 8-10 Children 10-12

	<p>Children 12-14 Junior Women/Senior NO LIMIT of participating teams. IN FINALS: 2 groups per country in each category. If there are less than 10 participating groups in a category, all groups will go to the FINALS, but only 2 per country in ranking.</p>
COMPETITION AREA	Competition Carpet - 13mx13m-interior of the line on wooden floor
TRAINING AREA	<p>There will be a warmup zone in a separate hall. There will be 6 carpets behind the competition area</p>
ENTRY FEES	<p>The non-reimbursable entry fee for the Mediterranean Countries Competitions (all children, all short and mix teams is):</p> <p>A group consisting of 1-6 gymnasts and max 2 coaches: 100€/ group. A group consisting of 7 or more gymnasts & max 3 coaches: 130€/group.</p> <p>Each team may include max 1 doctor and 1 other delegate.</p> <p>Extra accreditation over the limit of group number is 40€/ delegate.</p> <p>Deadline for definitive registration: 29th May</p> <p>The non-reimbursable entry fee for the Mediterranean Countries Competitions (Junior/Senior long program):</p> <p>A group consisting of 1-6 gymnasts and max 2 coaches: 150€/ group. A group consisting of 7 or more gymnasts and max 3 coaches: 180€ / group.</p> <p>Each team may have max 1 doctor and 1 other delegate.</p> <p>Extra accreditation over the limit of group number is 40€/ delegate.</p> <p>Deadline for definitive registration: 29th May</p> <p>According to IFAGG rules the registration after deadline will carry an additional charge of 100 euros per group (to be paid to the LOC).</p> <p>The organizer will send you the invoice after your registration on the KSIS system.</p> <p>The entry fee is NON-REFUNDABLE.</p> <p>PAYMENT INFORMATION</p> <ul style="list-style-type: none"> • The entry fee must be paid via bank transfer to the LOC bank account. • All bank details will be published later. • The participating delegations are responsible for covering all bank fees in connection with the bank transfers.

IFAGG reserves the right to invite judges.</p> <p>Delegations are responsible for all judges’ expenses (travel, accommodation and local transportation). Judges’ registration for LOC accreditation (on KSIS) must be done ONLINE by IFAGG members only.</p>

INSURANCE	<p>The Royal Spanish Gymnastics Federation, Federació Catalana de Gimnàstica and the IFAGG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The IFAGG Technical Regulations foresee that all participating delegations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g., cover note or photocopy of the valid policy).</p>
MEDICAL SERVICES	<p>The Local Organizing Committee will provide a first aid medical service, a doctor and emergency medical transportation in the competition area.</p>
ANTIDOPING	<p>IFAGG Code of Discipline.</p> <p>It's a condition of participation in IFAGG's activities that gymnasts and their assistants and representatives follow the national and international doping rules. All gymnasts and their assistants and representatives are obligated to know the doping rules. PERSONAL DATA PROTECITON	<p>Personal information of registered gymnasts, coaches, judges and volunteers are used in published official competition protocols, rgform.eu online environment, competition's/federation's websites and on social media channels. By registering to the event, the gymnasts, coaches, judges and volunteers are giving consent to publish visual materials (photos, videos) on which they might be displayed. In case the person does not consent with the aforementioned, the LOC and federation has to be informed in writing by the start of the competition. Only photographers and journalists with accreditations are allowed to take pictures and film the event.</p>
ACCREDITATION	<p>The Delegation will be accredited upon their arrival</p> <p>During the accreditation Heads of Delegations are required to:</p> <ul style="list-style-type: none"> • check the correct spelling of the names fo their entire delegation; • do a passport control of all gymnasts • show proof of medical insurance of all delegation members • do a music check • submit personal data protection declaration • make any necessary payments
VISA INVITATION	<p>All delegations requiring a visa must complete the visa request form and send it to the LOC (form can be found on the KSIS platform).</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the delegation member, as well as the city the visa application support letter must be sent to.</p> <p>Deadline: 29th May</p>
ACCOMMODATION SUGGESTIONS	<p>All hotel suggestions can be found on the attached ASAP document on the KSIS system.</p>

INTERNATIONAL TRANSPORTATION	Travel costs are the responsibility of each delegation. The Travel Schedule form must be filled out on the KSIS system by 31 st May.	
LOCAL TRANSPORTATION	Local Transportation (costs will be published together with the hotels) Local transportation will be provided only for the Delegation members who booked their hotel accommodation through the Local Organizing Committee.
