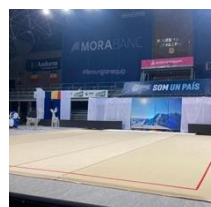

<b>RULES AND REGULATIONS</b>	All participants have to follow the IFAGG Rules and Regulations.
<b>DELEGATIONS INVITED</b>	All IFAGG members in good standing.
<b>EVENT FORMAT</b>	<p><u>SNOW WONDERLAND Preliminaries and Final competitions:</u> Only IFAGG members can register participating groups.</p> <p>Long/short program/Mixed team (only long program, following the new rules).</p> <ul style="list-style-type: none"> <li>- Children extra category 6-8</li> <li>- Children 8-10</li> <li>- Children 10-12</li> <li>- Children 12-14</li> <li>- Junior</li> <li>- Women/Seniors</li> </ul> <p>NO limit of participating teams. In FINALS - 2 groups per county in each category (if there are less than 10 participating groups in category, all groups will go to the FINALS, but only 2 per country in ranking).</p> <p>All gymnasts and coaches must have a valid license for 2025.</p>
<b>COMPETITION AREA</b>	Competition Carpet 13 x13 meters
<b>TRAINING AREA</b>	<p>1 warm up zone. 4 carpets behind the competition area.</p>
<b>ENTRY FEES</b>	<p>The Entry fee is:</p> <ul style="list-style-type: none"> <li>- A group consisting of 1-6 gymnasts &amp; max. 2 coaches 70,00 € / group.</li> <li>- A group consisting of 7 or more gymnasts &amp; max. 3 coaches 80,00 € / group.</li> <li>- Extra accreditation over the limit of group number is 40 € / delegate.</li> </ul> <p>Deadline for preliminary registration: 20 January, 2025. Deadline for definitive registration: 20 February, 2025.</p> <p>Points to note:</p> <ul style="list-style-type: none"> <li>- Please, note the additional charge for the group registrations after the deadline is 100 € / group (to the LOC).</li> <li>- The organizer will send you the invoice after your registration in KSIS system after 20<sup>th</sup> of February.</li> </ul> <p>The entry fee is NON-REFUNDABLE.</p> <p><b>PAYMENT INFORMATION</b></p> <ul style="list-style-type: none"> <li>- The entry fee must be paid via bank transfer to the GAEE Andorra bank account.</li> <li>- All bank details will be noticed in the invoice.</li> <li>- The participating delegations are responsible for covering all bank fees in connection with the bank transfers.</li> </ul>
<b>JUDGES</b>	<p>Proposals for judges' registration must be submitted in KSIS by February 20, 2025. After the registration deadline, the organization will confirm the final list of judges.</p> <p><u>Warning: No request will be accepted after the deadline.</u></p> <p>All judges must have a valid judge license for 2025 and comply with the IFAGG Code of Ethics for judges.</p> <p>The organization will cover the judges' fees, accommodation, and meals during the competition period. All other expenses must be covered by the delegations.</p>

<b>INSURANCE</b>	<p>GAEE Andorra will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The IFAGG Technical Regulations foresee that all participating delegations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p>
<b>MEDICAL SERVICES</b>	<p>Organizing Committee will provide a first medical aid service, a doctor and emergency medical transportation in the competition area.</p>
<b>ANTIDOPING</b>	<p><u>IFAGG Code of Discipline</u></p> <p>It's a condition of participation in IFAGG's activities that gymnasts and their assistants and representatives will follow the national and international doping rules.</p> <p>All gymnasts and their assistants and representatives are obligated to know the doping rules. The information of the prohibited substances and methods can be found on the WADA (World Anti-Doping Agency), <a href="https://www.wada-ama.org/">https://www.wada-ama.org/</a>.</p>
<b>PERSONAL DATA PROTECTION</b>	<p>By registering to the event, the gymnasts, coaches, judges and volunteers are giving a consent to publish visual materials (photos, videos) on which they might be displayed. In case the person is not consent with the previous, LOC and federation hast to be informed in written form by the start of the competition.</p>
<b>ACCREDITATION</b>	<p>The delegations will be accredited upon their arrival.</p> <p>During the accreditation you must check the correct names of their whole delegation and collect the accreditation cards of the teams in the delegation.</p>

	Entrance in Sport Hall will be ONLY with accreditations.
<b>ACCOMMODATION INFORMATION</b>	If you need assistance with transportation or accommodation, feel free to send us an email, and we will provide you with the necessary information.
<b>MEALS INFO</b>	Teams/delegation can order <u>lunch</u> at the competition hall. Lunch will be served on Saturday and Sunday, with additional payment.
<b>TICKETS</b>	Tickets will be sold at the front door on the day of the competition.  <u>One day ticket: 6€</u> <u>Two days tickets: 10€</u>
<b>PAYMENT</b>	All participants will receive by mail invoices from LOC for all expenses with bank information and payment deadline in each invoice. The participants are responsible for covering ALL bank fees in connection with the bank transfers for the competition.
